NOTICE is hereby given that West Sussex County Council propose to make permanent Orders under the provisions of the Road Traffic Regulation Act 1984, the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of St Mary's Drive, Grattons Drive, Leighlands, Chaucer Road, Marvell Close, Herrick Close, Milton Road and Parkway and, a prohibition of waiting 10am-11am and 2pm-3pm Monday to Friday on Milton Road.

The consultation for this proposal will start on 9 August 2017 and, AT THAT TIME, full details of the proposal in this Notice can be viewed on our website www.westsussex.gov.uk/tro. The website includes a response form for comments or objections.

The documents will also be available to inspect at West Sussex County Council, County Hall, Chichester during normal office hours, and at the Crawley Public Library, Southgate Avenue, Crawley during normal library opening hours.

Any objections or comments about the proposal must be received by 31 August 2017. STATEMENT OF REASONS FOR PROPOSING TO MAKE THE ORDER

The County Council in exercise of their powers under the Road Traffic Regulation Act 1984, propose to introduce a permanent Order the effect of which will be to introduce lengths of prohibition of waiting at all times (double yellow lines) on sections of St Mary's Drive, Grattons Drive, Leighlands, Chaucer Road, Marvell Close, Herrick Close, Milton Road and Parkway and, a prohibition of waiting 10am-11am and 2pm-3pm Monday to Friday on Milton Road.

Parking issues in this area have become commonplace with numerous incidences of obstructive and inconsiderate parking having been reported to both West Sussex and Crawley Borough Councils.

Vehicles are routinely parking in too close proximity to the junctions of St Mary's Drive, Leighlands, Herrick Close, Marvell Close, Chaucer Road, Parkway, Milton Road and Grattons Drive so as to obstruct visibility for drivers exiting the junctions and pedestrians crossing the roads. Parked vehicles present a particular hazard for pupils walking to and fro Milton Mount Primary School. East Crawley County Local Committee approved progression of a Traffic Order to resolve this problem.

Since the introduction of waiting restrictions in Milton Mount Avenue and Pound Hill South area the negative parking trends have unfortunately migrated to other junctions in the area.

It is proposed to introduce lengths of double yellow lines to prohibit vehicles from parking on the junctions to enforce Highway Code Rule 243. This aims to discourage drivers from parking in unsuitable locations and will mean that enforcement action can be taken against drivers contravening the waiting restrictions.

To dissuade all day parking in residential streets and alleviate congestion it is also proposed to introduce lengths of single yellow lines in Milton Road to prohibit waiting between 10am-11am and 2pm-3pm Monday to Friday.

This Order is proposed for avoiding danger to persons or other traffic using the road, to prevent damage to the highway and to facilitate the passage on the road of any class of traffic (including pedestrians).

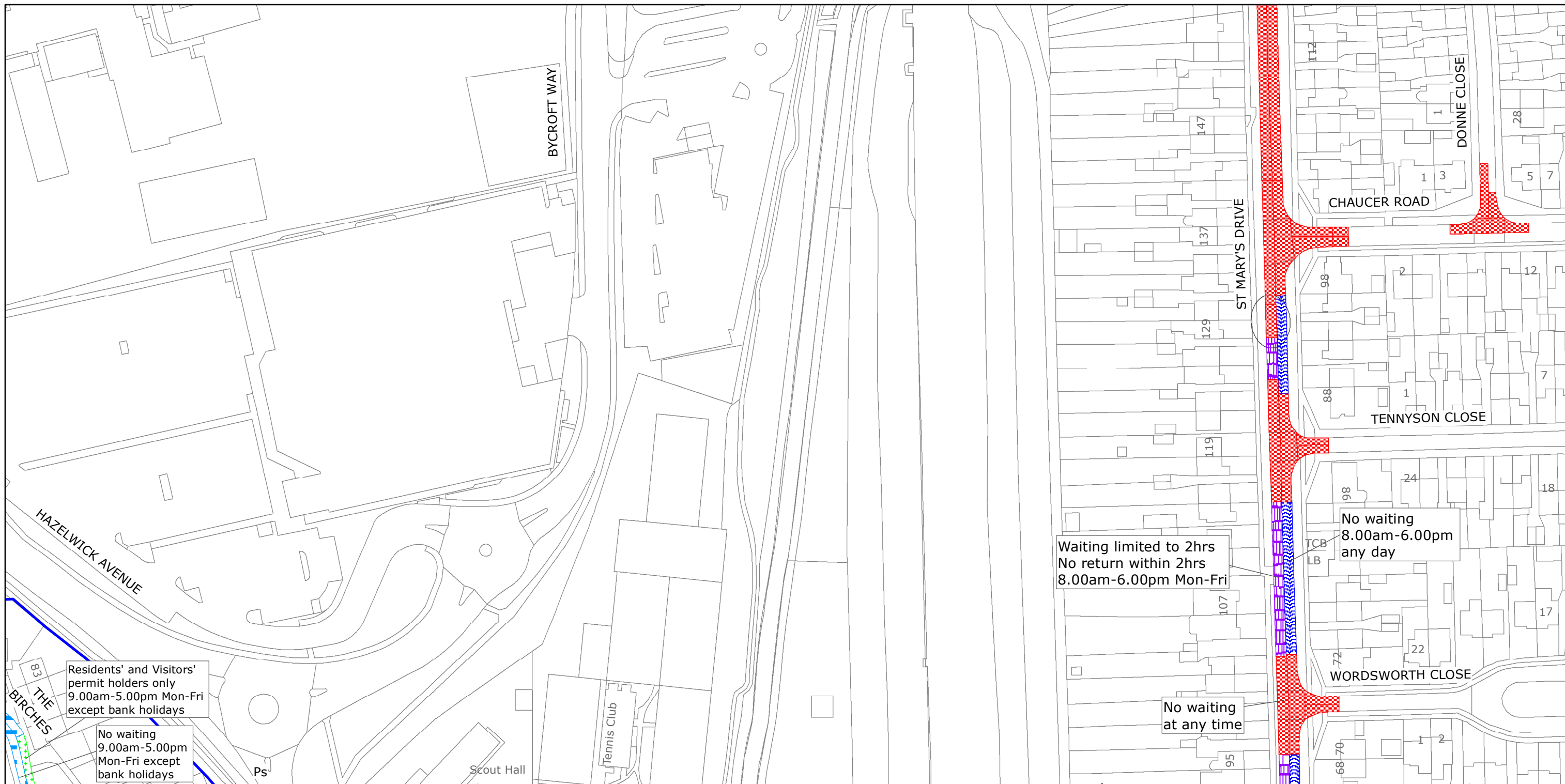

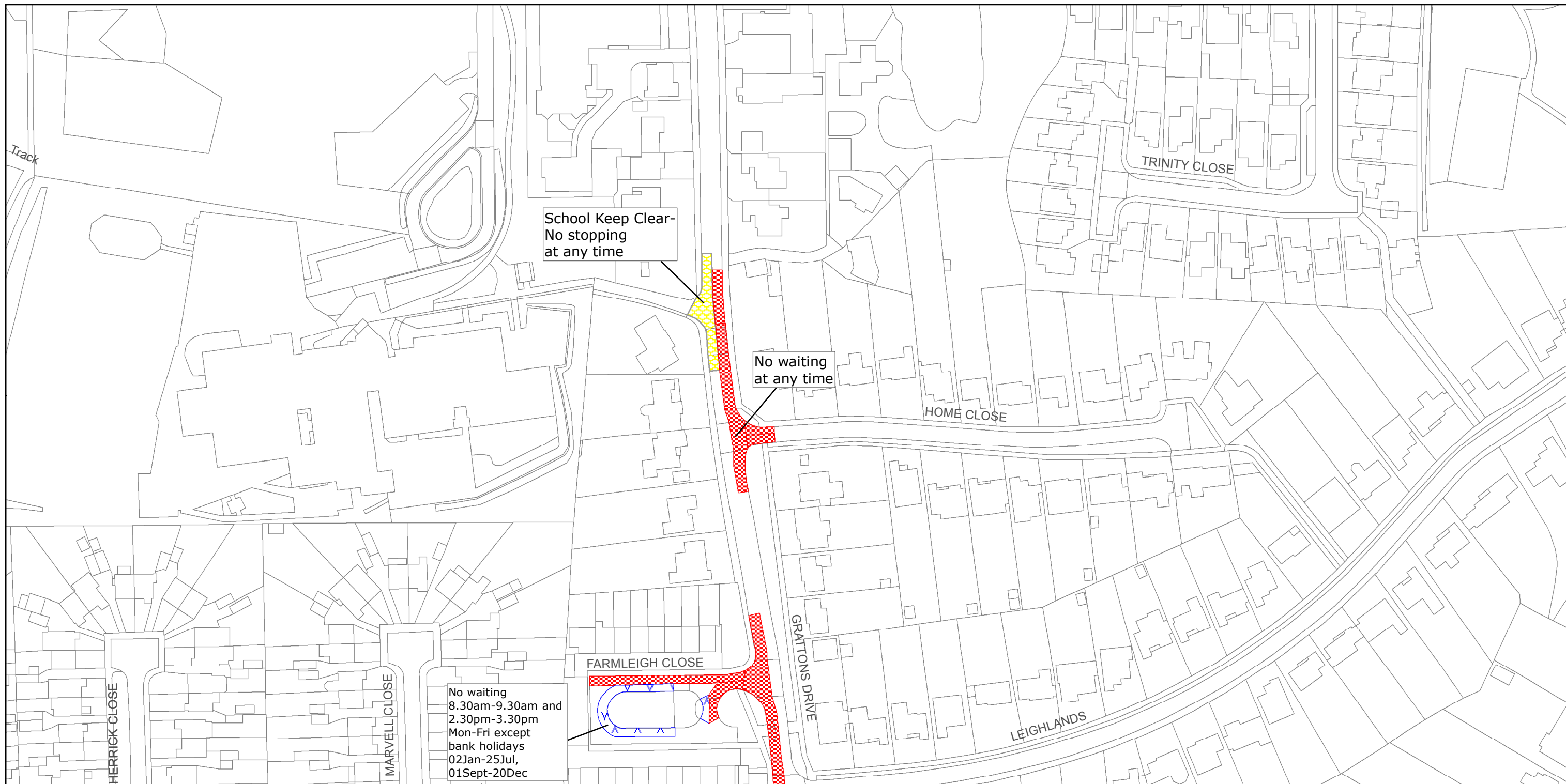

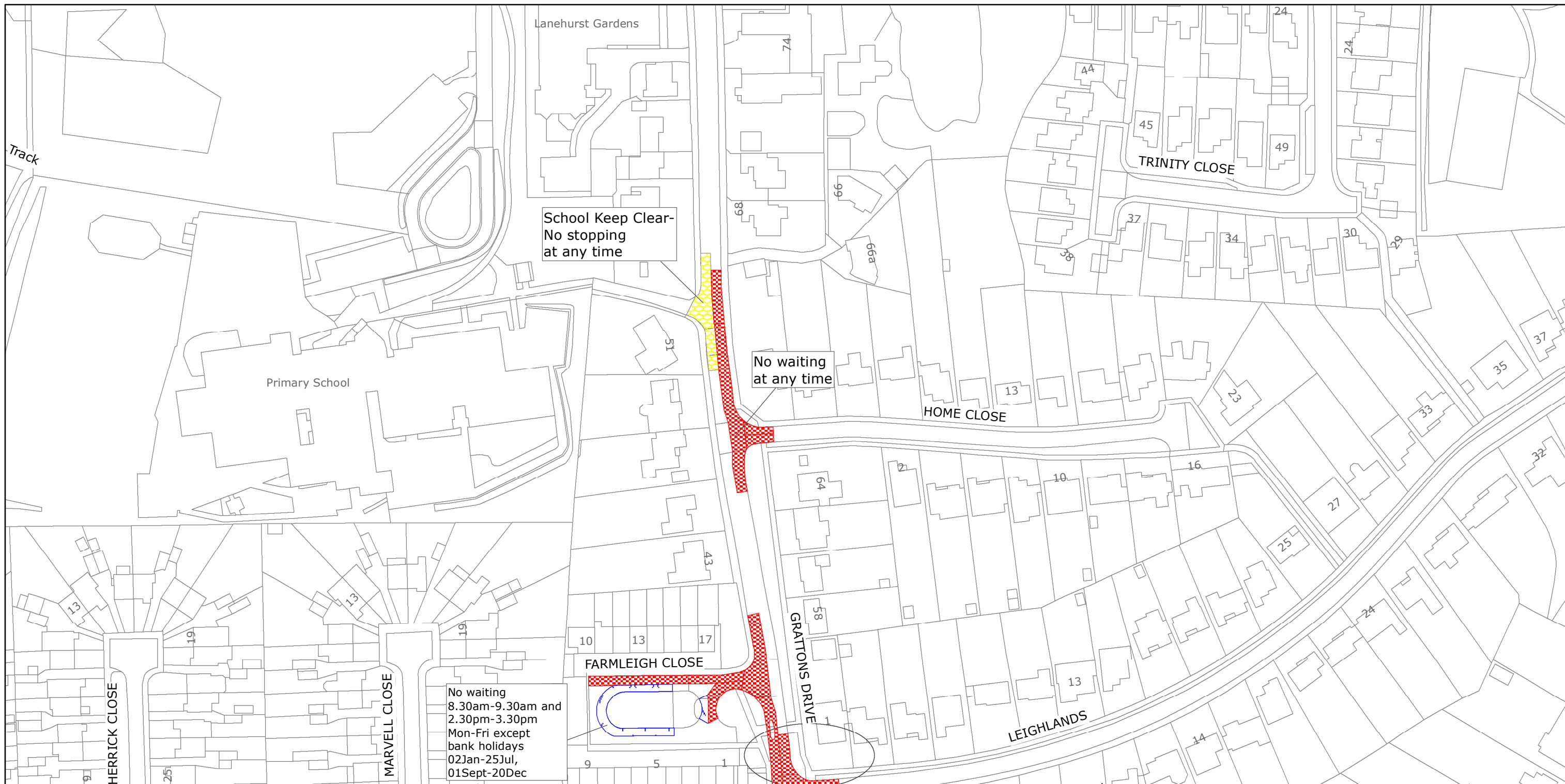

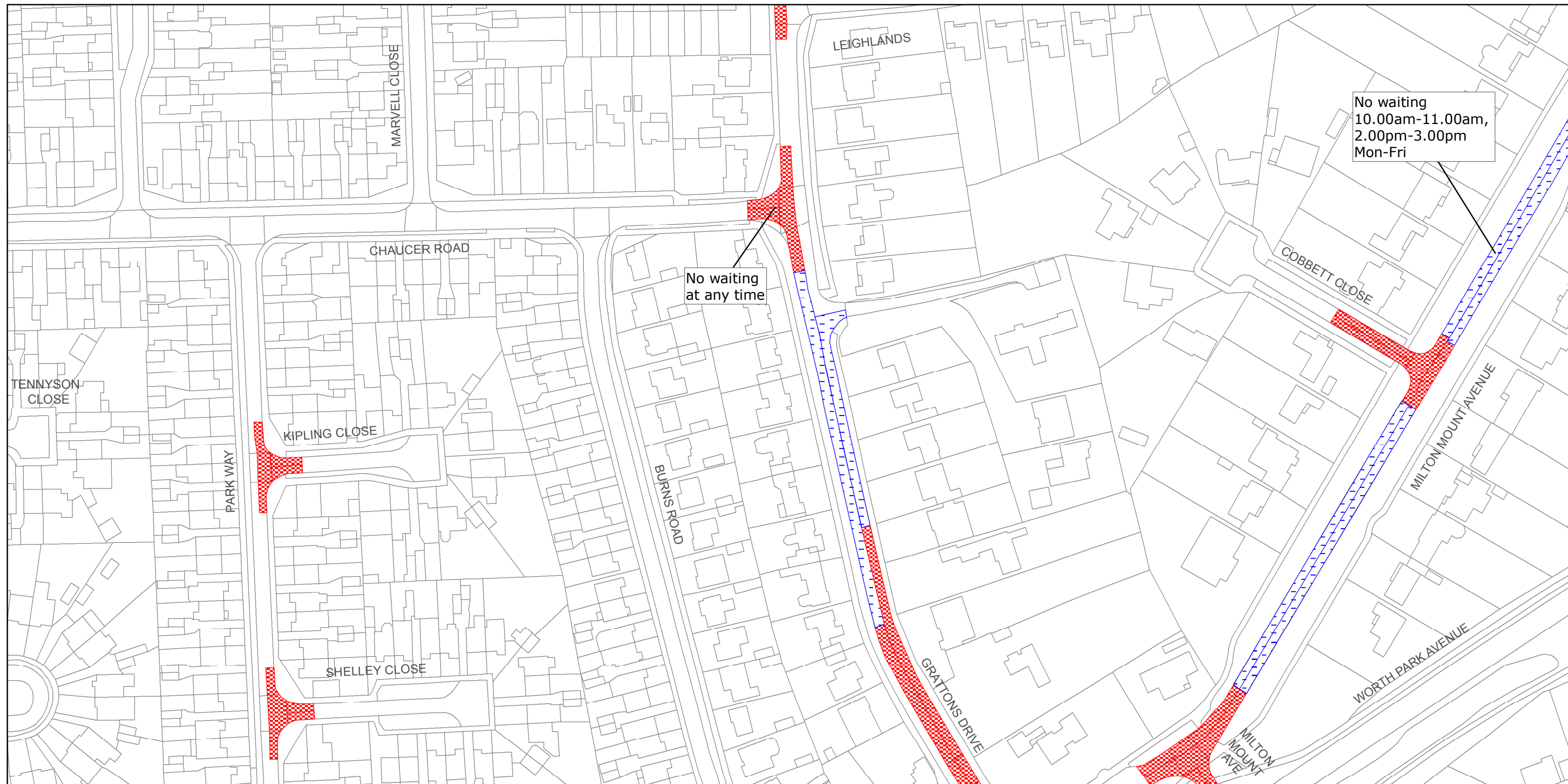

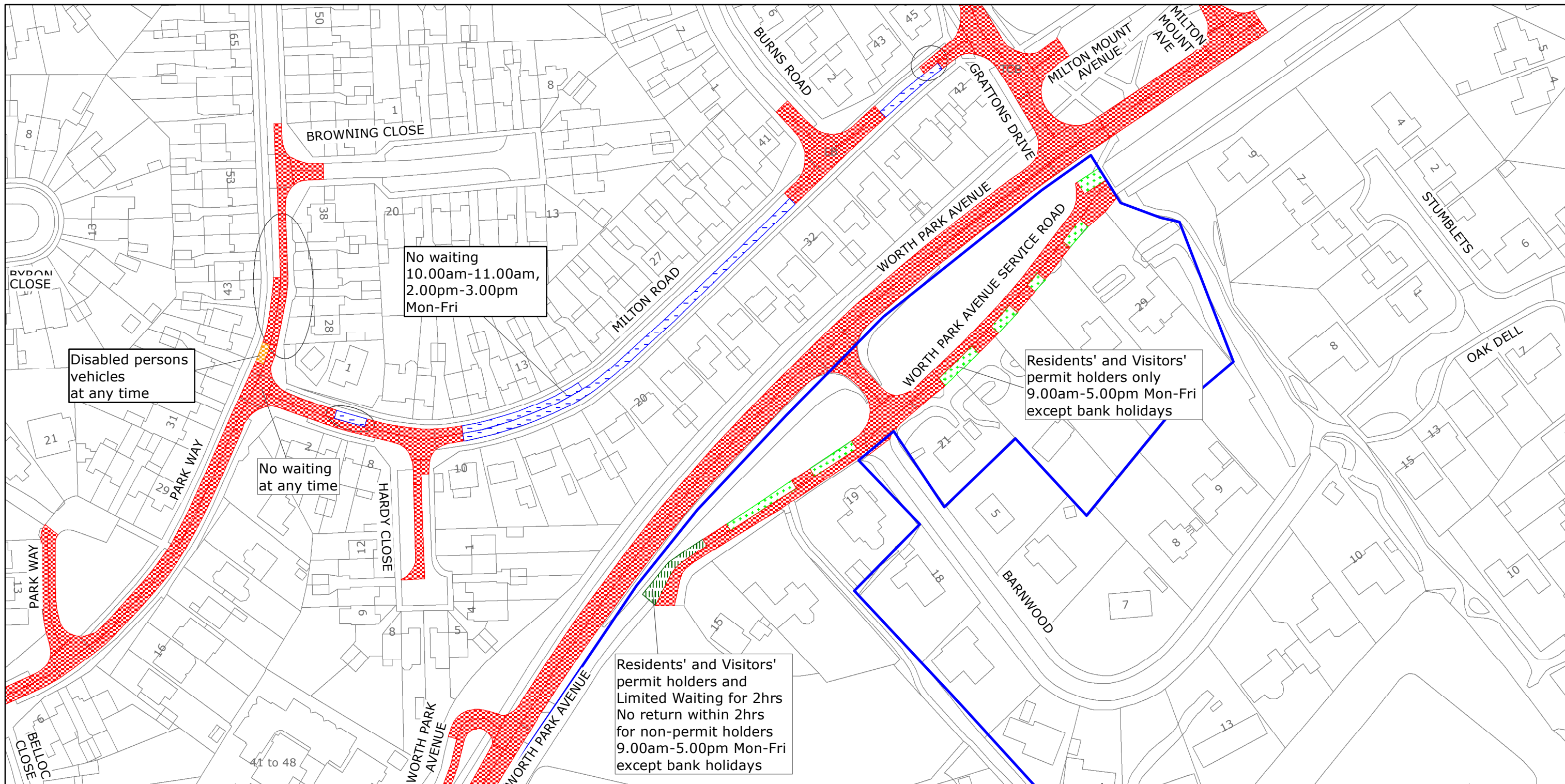
